The ability to sketch is a valuable and essential skill for understanding existing site conditions, for exploring and testing design solutions, and for conveying these ideas to others. **KEY NOTE SPEAKER: LANDSCAPE ARCHITECTURE AS CLIMATE INFRASTRUCTURE - NATURAL CAPITAL AND REGIONAL RESILIENCE**

**SESSION DESCRIPTION:** Landscape architects work at the exact scale where national disaster losses are generated, yet our profession’s contributions are routinely framed as amenities rather than critical infrastructure. This session reframes landscape architecture as climate infrastructure by connecting natural systems to the risk-reduction logic that actually drives capital investment decisions.

Drawing on SmithGroup’s climate practice in the Great Lakes region, this presentation introduces the concept of natural capital – the chain from natural asset to ecosystem service to benefit to value – and explores how landscape architects can translate design moves into the financial and performance metrics that clients, developers, and public agencies use to make decisions. Key frameworks include avoided cost thinking, ecosystem services valuation, and equity-centered performance measurement.

Attendees will leave with practical starting points for reframing their own work: leading with risk rather than amenity, making the case for what a landscape prevents rather than what it provides, designing for measurable performance, and making equity visible as a risk-reduction outcome rather than a co-benefit.

**Alicia Adams, PLA**, is a Principal and Climate Strategist at SmithGroup, where she leads resilience and adaptation work as part of the firm’s national IMPACT program. Her practice centers on repositioning landscape architecture as critical climate infrastructure – reframing natural systems from amenities into measurable risk-reduction assets. With more than a decade at SmithGroup rooted in Detroit and the Great Lakes region, and now based in Pittsburgh, Alicia focuses on helping design teams and clients communicate the value of nature-based solutions in the language that drives investment decisions: risk exposure, avoided damage, and ecosystem service value. A contributor to SmithGroup’s ASLA Climate Action Commitment, her work on green infrastructure and green gentrification in Midwestern cities informs her equity-centered approach to climate-resilient design.

## DESIGNING THE 9LINE: A VISION FOR MOBILITY AND PLACEMAKING

**SESSION DESCRIPTION:** Join us for an inside look at Oakland County’s 9Line, an ambitious vision to transform the Nine Mile corridor into a signature regional landscape and non-motorized connection. Spanning ten communities, the 9Line weaves together cultural destinations, parks, and neighborhoods while creating new opportunities for recreation, mobility, and community identity. This session highlights the planning and design work led by OHM Advisors, including the landscape design for Oak Park and the firm’s leadership in the Phase 1 and Phase 2 planning efforts and implementation strategy. Presenters will explore the corridor’s history, existing conditions, and the opportunities and constraints that shaped the project’s vision. Attendees will learn how this collaborative effort is advancing a new model for suburban corridor transformation, delivering recreation access, strengthening local economies, supporting public health, and expanding equitable access to open space.

## DESIGNING THE 9LINE: A VISION FOR MOBILITY AND PLACEMAKING

**Eric Dryer, AICP**, is an accomplished urban planner with extensive experience in creating sustainable and vibrant communities. As a Principal at OHM Advisors, and the Studio Manager for the Michigan Planning and Landscape Architecture team, Eric brings a wealth of knowledge and expertise to the projects he undertakes, advocating for data-driven, holistic, and innovative design solutions.

Based in Detroit, Eric is deeply passionate about improving cities and the quality of life for residents. His keen eye for detail and strategic approach to planning have led to the successful completion of numerous projects that have positively impacted communities across the Midwest. Eric is passionate about finding ways for infrastructure, development, and natural spaces to work together in harmony and he brings an approach that relies equally on data, community input, and design to help communities find feasible solutions to the advancing communities.

## LANDSCAPES UNDER PRESSURE: HOW PERCEPTION SHAPES USE IN A CHANGING WORLD

**SESSION DESCRIPTION:** Landscapes are changing, and so are the people moving through them. From the dunes, trails, and seasonal rhythms of Sleeping Bear Dunes National Lakeshore and Glen Arbor to the open gathering spaces of The Diag at University of Michigan, ecological pressures, technology, tourism, and social change all influence how spaces are experienced and used.

This session explores how people respond to exposure, refuge, visibility, movement, and social pressure within public landscapes, and how those responses may be shifting in a rapidly changing world. Through Michigan based examples, participants will look at how gathering, circulation, lingering, and interaction patterns can reveal deeper changes in perception and comfort.

The presentation also invites designers to consider how their own lived experiences, personalities, comfort thresholds, and ways of perceiving the world may subtly shape the spaces they create. Through observation, reflection, and a short interactive exercise, attendees will explore how greater awareness of perception can strengthen design thinking and support more responsive, human-centered landscapes.

**Danielle Groth, RLA**, is a 1993 graduate of Michigan State University with a Bachelor of Landscape Architecture. She began her career with the City of Detroit Parks and Recreation Department and later practiced with Land Design Studio and SmithGroup JJR, focusing on public landscapes, institutional projects, and community-oriented spaces.

Over time, Danielle’s landscape architecture career shifted toward the healing arts as she deepened her understanding of how nature and designed environments influence human well-being. She is now co-owner of Angel Whispers Healing Center, where her work centers on perception, nervous system regulation, and the emotional experience of self and place.

Drawing on both design and healing arts, Danielle bridges landscape architecture with neuroscience informed and trauma aware approaches. She is the co-author of Shift Your Lens: Healing Your Stories™, a program that helps people understand the lens through which they experience the world.

## TREES AS INFRASTRUCTURE: LEVERAGING TECHNOLOGY FOR PRESERVATION

**SESSION DESCRIPTION:** Trees are often discussed as amenities but rarely evaluated or managed as infrastructure. This session focuses on how landscape architects can use technology and data to make informed, defensible decisions about tree preservation within real development constraints.

This course examines how tools such as sonic tomography, resistance micro-drilling (Resistograph), and carefully coordinated tree surveys can be applied to assess structural integrity, quantify risk, and prioritize preservation efforts. Through real-world case studies, attendees will see how these methods influence site planning, grading, and construction decisions, balancing preservation goals with budget and feasibility.

The session emphasizes practical application: when advanced testing is appropriate, how to interpret results, and how to translate findings into design and development strategies. Participants will leave with a clearer framework for treating trees as critical infrastructure, making preservation decisions that are both technically sound and economically realistic.

## THE POWER OF LANDSCAPE ARCHITECTURE TO INFLUENCE URBAN SOIL-BUILDING THROUGH COMMUNITY-SCALE COMPOSTING

**SESSION DESCRIPTION:** There is real tension facing Michigan cities and communities regarding how to sustainably manage food waste through composting systems. The tension exists between an urgent imperative to reduce climate impacts caused by methane emissions generated from food waste in landfills, and how that waste is diverted and composted in responsible, equitable ways, especially on residentially zoned land. Now is the perfect time for landscape architects to bring their unique ability to manage tensions while designing productive land-based solutions to the table. No matter what scale composting is done “The What Abouts” are the same... What, you want to put that where? What does it look like? What about the smells? And What about the doggone rats?

The coupling of “design” and “landscape architecture” with compost site planning and infrastructure development has the potential of not only addressing these 3 could be “showstoppers”, it can also help facilitate the transformation of people’s relationship with food scraps from “waste” to “resource”. Informed, engaged landscape architects have the power to positively influence perspectives about the use of residential land for building soils that address urban systems challenges such as flooding, heat island effect, poor air quality, climate change, food insecurity, and chronic health conditions. Our aim in this interactive session is to explore the relationship between landscape architecture and composting, to provoke curiosity and inquiry, and to share a pathway for taking action now.

## THE POWER OF LANDSCAPE ARCHITECTURE TO INFLUENCE URBAN SOIL-BUILDING THROUGH COMMUNITY-SCALE COMPOSTING

**Charles Cross, ASLA**, is the Director of Landscape and Urban Design at the Detroit Collaborative Design Center and an Adjunct Professor at the University of Detroit Mercy School of Architecture & Community Development (SACD). Charles holds a Bachelor of Science degree in Agriculture from Western Michigan University, a Bachelor of Science in Landscape Architecture and a Master of Urban Design degree from The City College of New York. He has experience in the public sector, with the U.S. Department of Agriculture and Michigan Department of Natural Resources as well as private sector work with SmithGroup/JJR.
